CHILL OUT ON THE CHEAP

Don't wait until that outdated central air conditioning unit quits working on a sweltering summer day. Replace your older, less efficient model now with a new, high-efficiency unit and your proactive purchasing could be rewarded with an Act On Energy discount. Plus, a new model could **save you up to \$200 every year in energy costs.**

Your discount could be as high as \$720 for a high-efficiency cooling unit, depending on the new equipment you have installed. To be eligible for the incentive, you must work with a qualified Act On Energy Program Ally HVAC contractor. Incentives are also available for replacement of a non-working central air unit.

AMEREN ILLINOIS UTILITIES FILE RATE REQUEST

Every time you flip a light switch or turn the knob on the stove, we know you're counting on us. It takes a vast network of pipes, wires and people to deliver the electricity and natural gas you rely on, 24 hours a day—every day.

To ensure we can continue to provide the safe, reliable energy to meet your needs, the Ameren Illinois Utilities (AmerenCIPS, AmerenCILCO and AmerenIP) filed rate increase cases on June 5.

The proposed rate increases would not take effect until May 2010 and will affect the charges for delivering electricity and natural gas to customers. (The supply charges on your bill are based on market prices.)

While we work hard to keep our expenses down, the costs of delivering energy—from utility poles and pipes, to fuel and financing costs—continue to go up. When our costs of doing business rise, we need to adjust our prices to continue serving your needs safely.

BENEFITS OF A RATE INCREASE

A rate increase provides the funding needed to strengthen, expand and update our energy delivery system so it's safer, more reliable and able to handle growing demand. That way, the energy we all depend on will be there every day.

WHAT THE PROPOSED RATES MEAN TO YOU

To help you understand what our rate request means specifically to you, the effect of the requested rates are printed on this month's bill. Look at the bottom of the bill, under "Important Information," to see what your costs would be if the proposed new rates take effect.

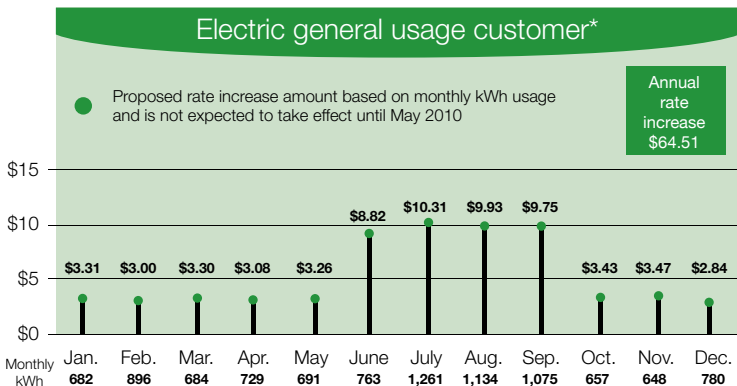

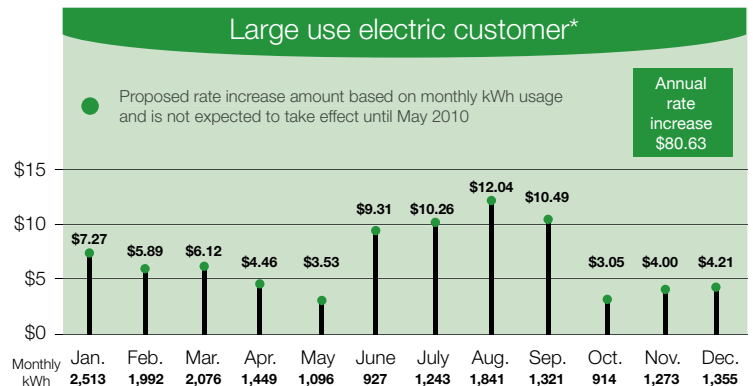
