- 2. Letter of Credit unconditional and irrevocable, issued by a reputable financial institution acceptable to Ameren. The Letter of Credit shall be issued in form, substance and amount acceptable to Ameren.
- 3. Bond issued by a reputable surety or financial institution acceptable to Ameren in favor of Ameren Services. The Bond shall be issued in form, substance and amount acceptable to Ameren.

- c) Maintaining at least 2 of the designated commercial paper or long-term bond ratings;
- d) Providing an unconditional guaranty from an affiliate of the Applicant who maintains at least 2 of the designated commercial paper or long-term bond ratings.

Ameren reserves the right to deny service to an Applicant failing to demonstrate creditworthiness or provide an acceptable form of security.

Ameren will treat all financial statements provided by Applicant in a confidential manner.

Applicant will promptly notify Ameren if any financial or credit application information changes.

Applicant represents and warrants that all information (including financial statements) now and hereafter supplied by or on behalf of the entity identified above to Ameren is true and correct and does not omit any information supplied to be materially misleading or incomplete.

Applicant hereby authorizes Ameren to obtain any information that may be required relative to this Application from any source, including Applicant's financial and trade references. Applicant also hereby authorizes each source to provide such information.
