

<u>1. Electric Vehicle Partner Network Membership Application</u>

1.1 To be considered a member of the Ameren Missouri Electric Vehicle Partner Network, each applicant must submit a i) completed Application Form, ii) current certificate of insurance from a carrier acceptable to Ameren Missouri, and iii) proof of good standing (three customer references). Ameren Missouri, in its sole judgment and discretion, will make the determination(s) as to whether the requirements set forth relating to any aspects of Electric Vehicle Partner membership have been met or whether good cause exists to deny Electric Vehicle Partner membership.

1.2 Within 30 days of receiving a completed application, Ameren Missouri will make a determination on whether this application for Electric Vehicle Partner membership is approved or denied. The Electric Vehicle Partner Membership Letter will be sent via email to the Applicant. Applicant approval will be effective as of the date of letter issuance from the Program, after the orientation training is complete.

1.3 Members will be subject to these terms and conditions and all program-specific terms and conditions for participation. 1.4 Electric Vehicle Partner membership will be effective for a term of one calendar year from the date of the Application Approval e-mail and will automatically renew each year on the anniversary of such Application Approval e-mail for an additional one year period, unless otherwise suspended or terminated in accordance with these terms and conditions, or any program specific terms and conditions. All Electric Vehicle Partner memberships shall terminate no later than the end date for the 2020-2022 Program Cycle.

1.5 Ameren Missouri Electric Vehicle Partner, Member may be listed on the Ameren Missouri Electric Vehicle program website, http://www.ameren.com/missouri/company/environment-and-sustainability/electric-vehicles showing their approved participation in the Electric Vehicle Partner Network after at least one representative has attended a group or individual orientation.

2. Membership Responsibilities

2.1 Member must comply with all laws and maintain all appropriate licenses, registrations, and certifications for the work it is performing.

2.2 Representation and Conduct

Member agrees to represent its business in an ethical, professional manner and as an independent contractor and at no time will it represent its business as an agent or representative of Ameren Missouri. Member will act as an independent contractor to provide services to its customers, and no employee of Member will be consider ed, for any purpose, to be an employee, agent, partner or representative of Ameren Missouri. Any contracts between Member and its customers or any third parties shall clearly and conspicuously express that no agency relationship exists between Ameren Missouri and the Member. Member has no power or right to bind Ameren Missouri or act on its behalf when dealing with customers or third parties. Member and Ameren Missouri shall not exercise any control or supervision of one another, nor be responsible for each other in the performance of any service.

2.3 Member understands that there will be inspections and verifications of Electric Vehicle Partner work in accordance with policies and procedures of each of the Ameren Missouri programs. Member must cooperate with these inspections and verifications, and continue to perform at an acceptable standard. Inspections will verify the project for program purposes only, and no warranty for any purpose is expressed or implied. If Member does not perform at an acceptable standard and, as a result, has its participation as a Electric Vehicle Partner terminated, Member will no longer be entitled to any Electric Vehicle Partner benefits.

2.4 Member must maintain good customer service

3. Performance Monitoring

^{3.1} Electric Vehicle Partner performance will be monitored to measure participation rates. Ameren Missouri will track Electric Vehicle Partner performance by program application. Key Performance Indicator (KPI) metrics will be used to rank members and report on performance.

3.2 A Quality Control and Verification Plan will be implemented for all Electric Vehicle Partners and shall include:

Submitted projects may be subject to pre and post installation inspections. These inspections will be assigned based on project type and project size and may be performed as part of a random sampling or for cause. Electric Vehicle Partners with a previously associated problem application or failed inspection will be subject to 100% installation inspection. When a sufficient number of applications are

deemed to be satisfactory, inspections will proceed according to general Program specifications. To ensure application and project quality, Members shall comply with the Ameren Missouri Electric Vehicle Partner Continuous Improvement Plan. Agreeing to this Plan will require the Member follow outlined processes in order to resolve persistent quality issues and may result in the Member's removal from the Electric Vehicle Partner Network if they do not comply or if the issues persist. 3.3 The Electric Vehicle Partner Network will be continuously evaluated and remain flexible, so as to refocus the program as necessary to achieve Program performance goals. Members may be added to the Network, and Members may be removed for continued nonperformance or poor performance.

4. Membership Benefits

4.1 Ameren Missouri will provide Member with informational training materials and additional training as required by each Ameren Missouri program for which Member has been approved.
4.2 Once approved as an Ameren Missouri Electric Vehicle Partner and after signing and agreeing to the Ameren Missouri Electric Vehicle Partner Co-Branding Guidelines, Member is authorized to use Ameren Missouri's Electric Vehicle Partner logo consistent with Ameren Missouri logo usage guidelines, provided that Member submits the proposed materials for review and written approval by Ameren Missouri prior to such use. Electric Vehicle Partner shall immediately cease using all Program related logos upon termination of this Agreement.

4.3 Membership benefits tied to ranking, such as awards and performance tiers, are based on multiple components of Member performance and are assigned or granted solely at the discretion of Ameren Missouri.

5. Participant Relationship and Code of Conduct

5.1 Member understands that Ameren Missouri is not endorsing its business, or warranting or endorsing any equipment that may be sold by Member. Under no circumstances shall Ameren Missouri be liable to Member for any direct, indirect, special, consequential or incidental losses, costs or damages arising from or related to any representations, equipment or installation under the program.

5.2 Member will indemnify, reimburse, hold harmless and defend Ameren Missouri, as well as its directors, officers and employees, agents and other consultants from any claims, liabilities, damages, costs and expenses of any kind, including but not limited to all fees and charges of engineers, architects, attorneys and other professionals and all court or arbitration or other disputed resolution costs arising out of or connected in any way with any act or omission of Member, its employees, agents or subcontractors of any tier or any other entity or person for whom Member is liable, in the performance or nonperformance of services as an Ameren Missouri Electric Vehicle Partner member.

5.3 Ameren Corporation and its representatives shall have no responsibility for the discovery, presence, handling, removal, or disposal of or exposure of trade ally or any other persons to hazardous materials of any kind in connection with Member's participation in any Ameren Missouri program, including and without limitation asbestos, asbestos products, PCBs, or other toxic substances.

5.4 Without limiting the scope or extent of the protection afforded Ameren Missouri or the liabilities assumed by Member here in, Member and any subcontractors shall obtain and maintain in force for the entire life of this Agreement the following insurance and name Ameren corporation, its subsidiary and affiliates as additional insured on primary and non-contributory basis and include a severability of interest provision:

Commercial General Liability insurance on the premises and Services covered by this Agreement and specifically including, without limitation, contractual liability insurance to cover liability assumed by Member with combined single limits, per accident, of not less than \$1,000,000 for bodily injury, including death and property damage. Worker's Compensation insurance with statutory limits and employer's liability insurance with limits of not less than \$1,000,000. Comprehensive Auto Liability insurance which has minimum combined single limits for bodily injury and property damage of \$1,000,000 per accident. The Comprehensive Auto Liability policy shall include owned and blanket non- owned and hired coverage.

5.5 Member shall require their insurance carriers, with respect to all insurance policies, to waive all rights of subrogation against Ameren Missouri, its directors, officers, agents and employees, and Member shall indemnify Ameren Missouri against any loss or expense, including reasonable attorneys' fees, resulting from the failure to obtain such waiver.

5.6 Member shall, before the commencement of any Services, furnish Ameren Missouri with a certificate from an insurance carrier acceptable to Ameren Missouri stating that policies of insurance carrier acceptable to Ameren Missouri have been issued by it to Member and any subcontractors providing for the insurance listed above and that such policies are in force. All such certificate(s) shall state that the insurance carrier(s) will give Ameren Missouri thirty

(30) days prior written notice (by first class mail) of any cancellation or material change in such policies, addressed to Ameren Missouri, Attention: Efficient Electrification, P.O. Box 66149 MC 686, St. Louis, MO 63166-6149.

6. Withdrawal and Revocation of Electric Vehicle Partner Membership

6.1 Ameren Missouri, in its sole discretion, will decide on Electric Vehicle Partner Membership approval; Electric Vehicle Partner status may not be assigned. Member may discontinue participating as an Electric Vehicle Partner by notifying Ameren Missouri in writing of that decision. Ameren Missouri may suspend and or end Member's participation at any time, in its sole discretion, by notifying Member in writing of that decision or in accordance with the program requirements for any program for which Member has been approved as an Electric Vehicle Partner. Ameren Missouri reserves the right to terminate or modify the Ameren Missouri Electric Vehicle Partner Program at any time and without prior notice to Member.

6.2 Electric Vehicle Partner status may be terminated without penalty by Electric Vehicle Partner or by Program Representative for any reason, at any time. Written notice of termination must be sent by the terminating party to the non-terminating party by mail, fax or e-mail.



Ameren Missouri's

Electric Vehicle Partner Co-Branding Guidelines

Electric Vehicle Partner (EVPs) are a valuable part of Ameren Missouri's Electric Vehicle programs. We encourage EVPs to utilize co-branding opportunities to promote their business and the program. EVPs operate under an agreement with Ameren Missouri per the terms and conditions in the Electric Vehicle Partner Application.

ELECTRIC VEHICLE PARTNER LOGO REQUIREMENTS

Use of Ameren Missouri Electric Vehicle Partner Logos

• All instances of the Ameren Missouri Electric Vehicle Partner logo must be approved by the EV Team in advance of use.

• If the Ameren Missouri Electric Vehicle Partner logos shown below are used in co-branded pieces, they should be used in combination with the Electric Vehicle Partner's business logo

• Where possible, the Ameren Missouri Electric Vehicle Partner logo should be noticeably smaller than the Electric Vehicle Partner's business logo

• Two varieties of approved Ameren Missouri Electric Vehicle Partner logos are available: one full-color logo and one black and white logo

• The below Ameren Missouri Electric Vehicle Partner logos below are available for use by approved Electric Vehicle Partners who have agreed to adhere to these guidelines.



Electric Vehicle Partners may produce materials that are co-branded with the Ameren Missouri Electric Vehicle Partner logo, including:

- Brochures
- Websites
- Print advertisements newspapers, magazines, trade journals, etc.

All marketing materials created must use the high-resolution logos provided and be submitted to the Program for approval prior to printing or distribution.

Broadcast advertisements - TV, radio, etc.

Logo Staging Requirements

The Electric Vehicle Partner logo should never be used within a headline or sentence. Leave a minimum amount of clear space around the perimeter of the Electric Vehicle Partner logo equivalent to the height of the letter "A" in "Ameren". The logo should always be large enough such that the "A" in Ameren should have a height of 0.25" or larger. Anything smaller is prohibited.

Common Errors to Avoid

Do not:

- Redraw, alter, stretch, tilt, rotate or distort the signature
- Use a low-resolution or otherwise poor-quality reproduction
- Use the signature more than once per page
- Transpose the colors of the signature or use other colors in place of those in the approved artwork files
- Add other elements or symbols to the signature
- Crop or eliminate elements from the Electric Vehicle Partner Network logo

LANGUAGE AND MESSAGING REQUIREMENTS INCENTIVES

Do not refer to Ameren Missouri cash incentives as "rebates." They are "incentives" or "cash incentives."

TEXT REFERENCES

In text, Electric Vehicle Partners may use the terminology "an approved Electric Vehicle Partner of Ameren Missouri" or "Electric Vehicle Partner of Ameren Missouri." When referencing the Program, please use the following language: Ameren Missouri's Electric Vehicle Program.

WEBSITES

If an EVP's web site is co-branded, the page(s) that mention Ameren Missouri must include a link to the appropriate Ameren Missouri web page. The high-resolution Ameren Missouri Electric Vehicle Partner logo can be used on web sites, but must be noticeably smaller than the EVPs business logo.

APPROVAL PROCESS

For any co-branded material, EVPs must obtain approval for custom pieces directly from Ameren Missouri's Electric Vehicle Partne r marketing team. Approval will be provided within ten (10) business days.

AGREE TO TERMS

I have read, understand and agree to the terms and conditions of participation in Ameren Missouri's Electric Vehicle Partner Network listed herein, including but not limited to the requirements that my marketing materials must adhere to the logo and messaging guidelines listed herein. I further understand and agree that, unless my proposed material has received Ameren Missouri's specific preapproval, I do not have permission to use the Ameren Missouri Electric Vehicle Partner logo for any cobranding materials, and will utilize the logo to present myself as a Electric Vehicle Partner in the Ameren Missouri Electric Vehicle program.

Quality Control Evaluation

Summary

Quality Control Evaluation will apply to EVPs, contractors, or other program partners that have demonstrated an inconsistent adherence to program requirements (including items such as: program guidelines, Terms & Conditions, project applications, and any other program documentation). EVPs are subject to the Quality Control Evaluation after they have already been warned verbally and received written communication but continue to demonstrate the same behavior.

Quality Control Evaluation Procedure:

Step 1: Meeting Invitation

- EVP will receive a meeting invitation with the subject "Notice of Pre QCE Meeting"

- EVP will be advised of the potential need for QCE during the meeting and given an opportunity to discuss concerns or provide feedback on the projects in question

- The EVP will be issued a verbal warning that if they continue to disregard program requirement they will be subject to QCE and could potentially be removed from the Electric Vehicle Partner Network or suspended from participating in the program

- Meeting summary will be recorded and sent to the EVP as well as program staff

- If the EVP corrects all listed items, procedure ends here. Otherwise, proceed to step 2.

Step 2: Notification of QC Evaluation and Immediate Hold on Project Processing

- EVP will receive written notification that they are placed under QCE

- During QCE

No new projects will be accepted

Current projects will be placed on hold and are subject to audit

At program management's discretion, customers may be notified that their EVP has been placed under QCE and will be offered an opportunity to choose a different EVP No projects will be paid out

Step 3: QCE Project Audit

For projects in process, where documentation is received and project has not yet been paid, the following process will be implemented Projects will be reviewed for deviations from Program requirements. Such deviations will be noted in a QCE Report.

Customers will be advised that incentives may be adjusted for projects in all stages.

Field inspections will be conducted by program staff. All documents will be brought to the inspection and reviewed by the customer If there are more than 3 offenses or if the inspection fails, the EVP will be suspended from the program for 1 year.

Customers will be notified that their EVP has been suspended and will be offered to work with a different EVP.

Any new application received referencing the expelled EVP will be rejected and the customer attempting to apply will be provided the EVP list.

For projects that have already been paid, the following process will be implemented

A random sampling of projects that were completed within the past 2 years will be subject to additional field validation. This will be done to ensure the projects are still in compliance with program rules

In the event that the program review yields discrepancies between what was paid out and what the field visit revealed, contractor may be expelled from the EVP Network or asked to repay the incentives

Step 4: Notification of Reinstatement or Expulsion

If the findings from the QCE show the EVP does comply with program requirements:

The EVP will be permitted to resume all work

Customers will be advised that their EVP may restart work

Projects will be subject to random QCE

If the findings from the QCE show that the EVP is not in compliance with the program requirements

The EVP will be suspended from the program for one year from date of suspension.

Program staff will inform the EVP in writing that their company has been suspended and they are prohibited from participating as a vendor in the program

During this time new projects will not be accepted

Projects in process will be cancelled

No incentives will be paid out to the EVP

After one year, the EVP may request to participate in the program, but will be considered to be on probation. During the probationary period, if the EVP does not comply with program requirements, they will be permanently expelled from the program

Insurance Agent Instructions:

The company listed above has applied to become an Electric Vehicle Partner for the Ameren Missouri Electric Vehicle program. Ameren Missouri requires all approved Electric Vehicle Partners to maintain the specified insurance coverages described below.

Requested Certificate of Insurance Information: The insurance carried by the Company named above *must cover the work it will perform as a Electric Vehicle Partner of the program(s) that it is applying to participate in* and cannot have any exclusion for the type(s) of damage that it may cause as a result of that work. The required Certificate(s) of Insurance should specifically name Ameren Missouri as a Certificate Holder and must show, at the least, the following:

- Occurrence based Commercial General Liability Insurance (including products and completed operations coverage)
 - With combined single limits, per accident, of not less than \$1,000,000 for bodily injury, including death and property damage; and
 - o Ameren Missouri must be specifically named as an Additional Insured
- Workers' Compensation insurance with statutory limits and employer's liability insurance with not less than \$500,000.
- Comprehensive Auto Liability Insurance for bodily injury and property damage of \$1,000,000 per accident for each company-owned vehicle.

Please note that the Electric Vehicle Partner agreement may have additional types of insurance requirements. Please also note in your records that Ameren Missouri is a Certificate Holder and Additional Insured and should be notified of renewals, cancellations or changes in coverage.
